



**Kitsap Credit Union**  
**Notice of Board of Directors and Supervisory Committee Compensation**  
*Effective January 1, 2025*

Kitsap Credit Union (Kitsap) has established a Compensation Policy to provide reasonable compensation for its Board of Directors and Supervisory Committee members as allowed by Washington law and the Credit Union's Bylaws. The Kitsap Board believes the payment of compensation to Board of Directors and Supervisory Committee members will enhance the Credit Union's ability to attract and retain qualified individuals to represent the members.

The Board of Directors is responsible for the general direction and control of the Credit Union. The Directors typically serve on one or more committees. The Board establishes the strategic plan, annual budget and policies, and reviews the Credit Union's financial performance. The Supervisory Committee is responsible for overseeing internal controls, conducting an annual audit of the financial statements, and verifying the accuracy of members' accounts. The size and complexity of Kitsap requires Board of Directors and Supervisory Committee members with financial knowledge, diverse skills and dedication to meet the management demands of a competitive and highly regulated financial services industry. The time demands of Board of Directors and Supervisory Committee meetings, meeting preparation, regulatory training and continuing education warrants fair and reasonable compensation.

**Compensation Schedule for 2025.** The Credit Union provides reasonable compensation in the form of an annual stipend, paid quarterly, based on the leadership and position held. This structure provides compensation commensurate with the respective time demands of the different positions. The following compensation was approved for the Board of Directors and Supervisory Committee members for 2025:
